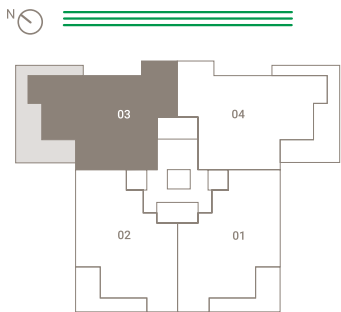

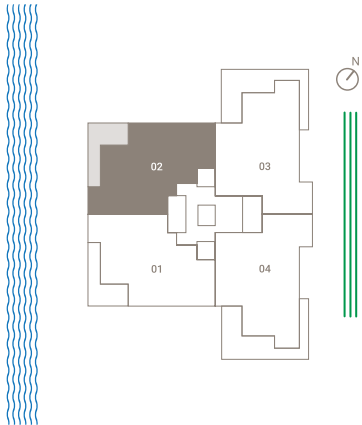

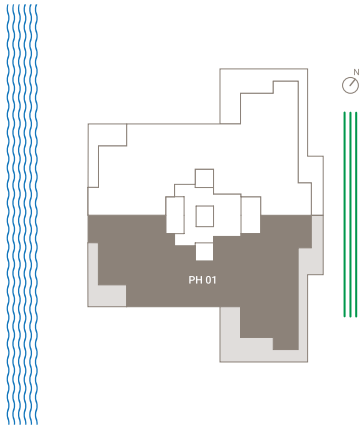


PENTHOUSE 01

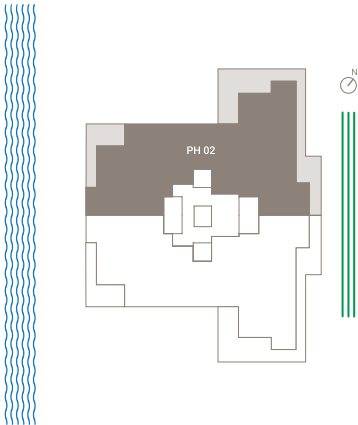
